GENERAL RIGHTS ALERT

There have been reports of the BATF showing up to people's homes requesting to verify that firearms they have purchased are in their possession. An example of this can be seen on this video: <u>CLICK HERE</u>

A couple of key takeaways from this situation: First, it is a blatant violation of your 4th Amendment right against unreasonable search and seizure for the ATF to request an individual to "prove" that they are in possession of a firearm they've purchased. Simply ask for them to produce a warrant, or politely leave your property.

The second thing to understand is that these "knock and talks" have come after the citizen has purchased more than one handgun within a five business day period at the same shop. This triggers a ATF Form 3310.4 (Multiple Handgun Sales and Reporting Form). If you want to avoid the possibility of this happening, or significantly reduce the chances anyway, then just wait the required five days in between handgun purchases and transfers.

The most important thing to understand is that WE WILL NOT be giving the BATF any information other than what we are legally obligated to give them. We consulted our attorney regarding requests from the BATF to provide additional sales/transfer records for clients who we have submitted 3310.4 forms, other than what is listed on those forms. He assured us that we are not obligated to provide sales/transfer information to the BATF or local law enforcement without a warrant (Local PD) or formal Attorney General request letter (BATF). These can only be obtained when the agencies are working an active criminal investigation.
